*For several years, participants at the Montreux Retreat have expressed interest to discuss Early Recovery in the context of humanitarian appeals. The overarching objective of the day's presentations and discussion will be to:*

- Ø *Develop a common understanding of how early recovery activities can and should be included in humanitarian appeals;*
- Ø *Increase mutual understanding of the opportunities and constraints donors face when funding ER activities through humanitarian appeals;*

*The humanitarian community has faced a surge in the number of violent attacks on aid worker since 2006. The ability of humanitarian agencies to operate in high-profile and large-scale emergencies is becoming increasingly constrained due to security threats and the shrinking of humanitarian space, leaving vulnerable communities without much-needed assistance. As agencies look to identify new ways to manage risk, the question is raised as to how these individual approaches fit into a coherent strategy that maximizes the security benefits for the broader community, and how funding can be made available in a manner that suits all partners. In this discussion, participants will seek clarity regarding the current system for assessing and managing security related risk in humanitarian emergencies; identify synergies among the approaches; and explore the most appropriate funding mechanisms for security activities in support of humanitarian action.*

*The overarching objective of the day's presentations and discussion will be to:*

- Ø *Explore ways to increase coherence in donor policies and mechanisms for funding security requirements associated with humanitarian action;*
- Ø *Identify areas to strengthen the international architecture for security risk management to best serve the broad humanitarian community;*
- Ø *Establish a dialogue among donors and between donors and partners regarding the concept of Safety and Security in humanitarian action.*

*Agencies in highly insecure contexts require significantly greater security expenditure to effectively manage and mitigate risks in order to maintain*

*humanitarian operations. Currently, the majority of funding for security flows through individual agencies, making the CAP a less relevant channel for security funding and not reflective of the level of requirements. Gaps exist both in practice and funding for common security platforms, and in coordination in funding, policy. Good practice should be improved by more open and active discussion between and among humanitarian donors and agencies.*
